

CHANGE IN CGM/ANDERSON REGISTRATION PROCESS

**Please read this carefully
as this affects your CGM/Anderson registration**

All CGM/Anderson credentials registration will now be done through Faithlife instead of through CHOG 24/7. Note this only affects registration with Anderson and NOT with TXM.

All credentialed ministers were sent a letter near their Anderson registration date during the last half of 2019 and first half of 2020 that instructed them to activate their Faithlife account and register through Faithlife instead of through CHOG 24-7. However, we know that very many ministers missed seeing it and/or continued to register through CHOG 24-7 during this past year.

If you registered through Faithlife last year, note that **it automatically set up auto registration renewal for you**. That means you do not need to register any more with Anderson since registration will now be done automatically for you every year.

If you registered through CHOG 24-7 last year, **auto registration renewal was NOT set up for you**. That means you will need to register this year through Faithlife. To do so, go to <https://register.jesusisthesubject.org/>. If you did not respond to that email that was sent out, before paying to register, a page will pop up for you to activate your new Faithlife account. **Note: you must use the same email address that you use with CHOG 24-7 or it will not work**. Once you pay, you will be registered for this year and will also be set up for auto renew in future years.

For retired ministers, after you have activated and entered into your Faithlife account, register by clicking on "Retired ministers register here" in *small print* at the bottom. **Retirees are also set up for auto registration renewal**.

To determine which system you registered through in the last year:

- a. **If you registered through a link** on either the TXM or Anderson web pages, you registered through CHOG 24-7.
- b. **If you registered through the email** the was sent out, you registered through Faithlife.

We recognize that some of you **do not remember which system** you registered through last year and, consequently, you **do not know if you are set up for auto-renew**. Of course if your Faithlife account is not set up at <https://register.jesusisthesubject.org/>, or if you happen to receive a registration reminder from Anderson, then you are not yet set up with auto-renew. Otherwise, here are two options:

- a. Wait until a few days after your annual Anderson registration date and then check your personal account at <https://chog24-7.org/> to see if you are still "active." If so, you were automatically renewed.

If you don't know your 24-7 email, or if you wish to change the email address being used, email Courtney Porter in Anderson at registration2@chog.org, or call 800-848-2464, ext. 2120.

Note that Anderson is using two different systems at this time: **Faithlife** and **CHOG 24-7**. **Faithlife is where registration is done**, and **CHOG 24-7 is where contact information changes are made**. To make changes to your account, such as your address or phone no., go to your personal account at <https://chog24-7.org/>.
